STORM ADVISORY set the pace early, angled off the rail into the far turn and yielded late in the stretch run. MCMULLEN COUNTY was unhurried early, swung into the six path in the far turn, rallied into the stretch and was gaining late. MIZZ WIZZ tracked the pace early, shifted into the three path in the far turn and flattened out late in the stretch drive. SERGIOS PRIDE was well placed early, fanned into the five path in the far turn but lacked a late bid in the stretch. MOVE THE CHAINS was never a threat. WHERE'S WOODY was through after a half. LAFLOWMYLAXBRO was bumped and bothered at the start.
