

VICTORY MORNING prompted the pace just off the rail, drew off around the turn, held clear through the stretch under a drive. LIANA ARIEL forced the issue four wide, angled to the inside on the turn and was easily second best. IMPULSE POWER stalked the leaders, three and four wide, lacked the needed rally. GLITTERING JUSTICE set the pace on the rail, gave way around the turn. HERO'S SPOTLIGHT prompted the issue from the inside, had little left after three quarters. SQUAB trailed along the inside.
